| 1 | PURPOSE |
| | The purpose of the International Jukskei Federation Development Committee (hereinafter referred to as IJF-DC) is the coordination and management of all development issues and to manage development to the benefit of International Jukskei. |
| 2 | REACH OF THE IJF |
| 2.1 | IJF-DC is a full-fledged sub-committee of the Exco of the IJF and is subject to the Statute of IJF. |
| 2.2 | IJF-DC manages: <ul style="list-style-type: none"> a) All matters relating to development at International level. b) Affiliated Countries and countries under development are members of IJF-DC. c) See categories of membership under Article 8 of the IJF Constitution. |
| 3 | FUNCTIONS |
| 3.1 | The functions and responsibilities of the Development are as follows: |
| 3.2 | Is responsible: <ul style="list-style-type: none"> a) the standardisation of development on an international level across all Jukskei playing countries. b) to research to improve development within the reach of the IJF in line with other sports codes. |
| 3.3 | IJF-DC will perform the following functions in the management of Jukskei as sports: <ul style="list-style-type: none"> a) is responsible for coordinating development of all international players b) manages all matters relating to the functions of IJF development (eg recruitment, development opportunities and initiatives); c) conducts research on development and recruitment methods of sports and implements them in Jukskei; d) reports annually to the IJF General Meeting |
| 4 | STRUCTURE |
| 4.1 | The structure of the IJD is defined in the Constitution of the IJF. See Clause 10.20.5. |
| 4.2 | The responsibilities of members of the IJD are defined in Article 3 of this Regulation. |
| 4.3 | The Director, Development is responsible to allocate specific tasks to members of the IJA and may co-opt additional specialists for specific tasks. |
| 5 | REQUESTS FOR DEVELOPMENT |
| 5.1 | Requests for development etc. must be submitted to the Secretariat of the IJF |
| 5.1.1 | Request is then directed to IJF-A and IJF-D |
| 5.1.2 | IJF – A will appoint facilitators and trainers to present the development. |
| 6 | MEETINGS |
| 6.1 | Meetings of the Committee shall be scheduled by the Secretariat, in consultation with the Director, at a time and place when it would be convenient for the majority of the Committee to attend the meeting or by means of a virtual meeting. |
| 6.2 | A quorum for a meeting of the Committee shall consist of two members |
